National High School Federation rules will be used with the following exceptions:

1. Games will consist of two 16 minute halves with a running clock. The clock will stop for free throws and time-outs only. If the score is within 10 points the clock will stop during the last 2 minutes of the game on all whistles. Half-time will be 3 minutes
2. Teams will have 3 time-outs per game. They ***DO NOT*** carry into overtime periods.
3. 1st Overtime period will be 2 minutes using a stopped clock. Teams will be granted one time-out in OT. If an additional OT is required it will be sudden death with no time outs allotted.
4. Game time is forfeit time. Teams will be permitted to play with 4 players.
5. The three point shot will be allowed for all divisions.
6. 28.5 basketball size will be used for all divisions except boy's 7th & 8th grades, which will use a regulation men's ball.
7. **NO ZONE DEFENSES IN THE 4th & 5th GRADE DIVISION.** Teams will be called for playing a zone when a defensive player is more than 8 feet from his/her opposing offensive player and the defending player's feet are in the "paint". . Officials for 4th & 5th grade teams playing a zone will display the illegal motion signal used in football.
8. **NO FULL COURT PRESS IN THE 4th & 5th GRADE UNTIL THE LAST 2 MINUTES OF THE GAME.**
Defensive players cannot pick up the offense until the ball crosses half court.
9. **(NO PRESSING IF YOUR TEAM IS UP MORE THEN 20 POINTS)**
10. Substitutions are permitted on dead ball situations only.
11. ***HEAD COACHES are responsible for all of their PLAYERS, COACHES and FANS.***
Tournament Director reserves the right to disqualify a team based on their fans behavior!!
12. Any player ejected from any game will not be allowed to participate for the remainder of the tournament.
13. Any coach who receives 2 unsportsmanlike technical fouls during the tournament will be ejected for the remainder of the tournament.
14. Players must compete in their own grade classification exception: players in a lower grade may participate in an older division. All players' grades 4 through 8 are eligible to participate but may play on only **ONE** team. There will be a division at each grade level for both boys and girls. If there are insufficient registrations in a particular grade level, it will be combined with the next grade (i.e. 4th and 5th) or possibly dropped from the tournament.
15. Pickup players will not be allowed after rosters have been submitted except for the following reasons: Injury, sickness, or insufficient numbers. All pickup players must be registered by 5:00 p.m. on Friday, December 7, 2018 Questions about player eligibility should be directed to Tournament Director, 352-1420. Or EMAIL **dunk@rswy.net**
16. Each team must supply their own basketballs for warm-up.
17. Adult coaches must accompany their teams in the dressing rooms during games and at all other tournament activities.
18. All teams will be guaranteed 3 games. **(NO more NO less)THIS IS A JAMBOREE NOT A TOURNAMENT!**
19. Games will be played at various school gyms.
20. **All entries must be received (in our hands) no later than by November 16 NO EXCEPTIONS!!**
21. The tournament will be posted on November 28 on our webpage www.rswy.net
22. The shoes worn into the facility cannot be worn on gymnasium floors. Shoes must be changed and be non-marking
23. The Tournament Director will render any necessary decision regarding situation that may develop which are either not addressed, or only partially addressed in the tournament rules.
24. Team packets may be picked up at the gym where you play your first game on Friday.
