Mayor Kaumo stated that with it being a new year, he would like to give a State of the City Address. As year one of the current City Council closes, he stated that it is an honor to represent Rock Springs as its Mayor and he commended City employees, elected City officials and the many volunteers who serve on the City's boards and commissions or for events for their service to the City. Mayor Kaumo also thanked his wife and family for supporting him in his endeavor as Mayor as well as the City Councilors' families for their support of Council Members as well. He stated that funding continues to be an issue and an aggressive approach will be taken to secure additional funding through the legislative process and the search for available grants will continue. The State's economic condition continues to decline, leaving fewer dollars available for cities and towns. The Direct Distribution from the State will be closely followed.

Statewide unemployment is at 3.8% compared to 3.9% in 2018, and the statewide economy remains steady considering that many jobs have been lost in the coal and natural gas fields; regardless, a revenue decline is expected. As the City moves into 2020, it will be conservative as oil prices and State revenues continue to decline sharply. The most recent disbursement for the City's share of sales tax for November 2019 activity was at \$1,432,112.05; which is 9% below what was received in January of 2019 and 13% below what was received last month.

The City has made positive changes to departmental function, which provides cost savings that are now being utilized to improve services to the community. The City's goal is to be transparent in all that is done and the Governing Body constantly strives to improve the quality of life for its citizens. The Bitter Creek reconstruction has seen much progress, which will remove residents and businesses from the flood plain in our downtown area, along with creating a more appealing creek channel with walking and bike paths to connect the east side of Rock Springs to the west side. In addition, the City is well on its way to reconstruct the First Security Bank building downtown, after receiving support from the Wyoming Business Council for funding of Phase I of this project. The State Lands and Investment Board will also meet this month for final approval of this funding. Mayor Kaumo thanked all who have helped to make this project happen, along with the City Council for their support of the project.

The City's first electronic charging station was installed downtown for electronic powered vehicles, which allows patrons to charge a vehicle while they shop, attend events or visit restaurants downtown with the only request being a donation to the URA efforts. A Golf Simulator has been installed at the Rock Springs Civic Center, which offers citizens options for recreation during winter months. City Leagues will begin shortly on the simulator.

Mayor Kaumo also announced that beginning in 2020, the City will begin its path towards eliminating the gas chamber used to euthanize animals when necessary. Although the City rarely utilizes the chamber, a policy will be implemented to include expanding the lethal injection and Trap Neuter and Release (TNR) programs for animals that find themselves in the City's shelter who cannot be adopted.

Infrastructure needs will also be addressed through the Specific Purpose Tax coming up on the upcoming election ballot, with the City identifying 6 critical projects to be proposed to tax-payers on this ballot. He encouraged voters to do their research, as questions and educate themselves prior to the upcoming election to clearly understand each of the projects and their importance to the City of Rock Springs.

Mayor Kaumo looks forward to the challenges ahead and working side-by-side with City staff and elected officials, as well as other city/county/state and federal agencies in a proactive manner to improve our great City. He thanked everyone for their support and wished all a healthy and happy New Year.
