City Council met in regular session on January 15, 2019. Mayor Timothy A. PRESENTATIONS AND PROCLAMATIONS

Presentation: Susie Von Ahrens, Rock Springs Box Art Committee

Susie Von Ahrens addressed the Governing Body and gave the microphone to Darcie Punches-Mickelson, who is also a member of the Rock Springs Box Art Committee. The Rock Springs Box Art Committee is hoping to follow Jackson, Wyoming and Missoula, Montana in their initiative to vinyl wrap power boxes around Rock Springs as a beautification project. Ms. Punches-Mickelson stated that no funding would be required for this initiative, and that all the Committee would like is the City's blessing to move forward with it. The Committee is considering following a theme, such as nationalities that would relate to Rock Springs. The plan is to work closely with Rocky Mountain Power and the Wyoming Department of Transportation to develop a step-by-step plan for the initiative, which would be presented to the City for approval.

Mayor Kaumo inquired about funding for the initiative and where it would come from. Ms. Von Ahrens responded that funding will come from state grants, the Wyoming Art Council grants, and Urban Renewal Agency/Main Street grants. Councilor Zotti asked where the power boxes are located, and it was clarified that there is one in front of Premier Bone & Joint, one in front of the Sweetwater County Fire Station, and one in front of Arthur Park. Paul Kauchich, Director of Engineering/Operations & Public Services, requested that an agreement with the City be developed. Mr. Kauchich also asked for clarification of whether these wraps would be placed on traffic signal boxes or not. Ms. Von Ahrens stated that they would not be placed on traffic signal boxes, only on power boxes.

Councilor Shalata asked what the life span is of the vinyl wraps, and Ms. Von Ahrens stated that they last approximately 5-7 years. Councilor Shalata asked who would be responsible to replace the vinyl once it has worn out. Discussion took place regarding a possible maintenance agreement in order to ensure that the City is not financially responsible for replacing the vinyl wraps used for this initiative. Mayor Kaumo asked that the Committee present a maintenance agreement and that the Governing Body would consider the proposal at that time.

PETITIONS

Sydney Shannon, Student Body President for the Rock Springs High School, approached the Governing Body to ask for participation in the "I Bleed Orange" Blood Drive, taking place on January 28, 2019 from noon – 6 p.m. at Bunning Hall at the Freight Station. She stated that Green River and Rock Springs are currently tied 5-5 and that this year's blood drive will be the tie-breaker. Ms. Shannon stated that the Student Body is hoping that if the City's leaders are

doing it, more participants will follow. She asked that participants in the blood drive wear their “I Bleed Orange” t-shirts to the game taking place on January 31.
