Parks Division Employees

Mayor Kaumo stated that this commendation has been pending for a while, to recognize a wonderful group of City employees who provide many public services to the citizens of Rock Springs. Not much opportunity is given to recognize these individuals. The virus issue has been present for some time now, but in the beginning of the year, Mayor Kaumo noticed that the City looks fantastic. People who are visiting the area notice our gateways and we are always striving to improve those. Employees who have worked on the Parks crew were named off; Regina Webb was given recognition for her excellent care of the flowers in the downtown area. Mayor Kaumo wanted to recognize those individuals who are out on the ground doing the good work. Mark Lyon, Parks Superintendent, stated that his crew appreciates it and that not much recognition is

regularly given, but they are always in the background putting things together and making things look good. The Parks employees are the ones that do the heavy lifting and the ones who are relied on to keep the City looking good, both for citizens and tourism. In the winter, 3.5 acres of parking lots are plowed, and many sidewalks are also kept clear in the winter. Many trees are fertilized and treated, along with 26 park locations to maintain. Many amenities are maintained by his staff. Thousands of irrigation projects are performed every year. The Parks Department assists and works with every department within the City. Mr. Lyon recognized Bimbo Chick in particular, for his tenacity and his enthusiasm as the Parks Maintenance Crew Supervisor. Mr. Chick tells everyone on the Parks Crew every morning on their way out the door that today will be a fun day. The Parks Department believes that the quality of the community is very important, and they go above and beyond, and consistently do more with less. Mayor Kaumo echoed Mr. Lyon's comments about Bimbo Chick, stating that he is a great leader and he takes the time to teach. Both of his sons have had the opportunity to work for Mr. Chick. Mr. Lyon thanked his crew for everything they do every day. Mayor Kaumo added that their hard work is much appreciated. Running fiber through the green belts has caused quite a mess, but he is sure that the Parks Crew will ensure that in spring, the grass will be green and flowers will be blooming.

PRESENTATIONS AND PROCLAMATIONS

City of Rock Springs FYE 2020 Audit Presentation: McGee, Hearne and Paiz (New Business Item #1)

Brittany Wilson, Senior Manager at McGee, Hearne and Paiz, LLP, stated that page 1 and page 2 are the independent auditor's report, regarding whether financial statements from the City of Rock Springs conform with accounting standards. The City received an unmodified, or clean, audit for Fiscal Year 2020. The financial statements were summarized, which is in essence, a balance sheet, stating the short and long term assets and liabilities for the City. The income statement, when compared to prior years, has showed significant increases to public safety expenses, which relate to increases from the Wyoming Retirement System and includes both police and fire retirement accounts. Statements of revenues, expenditures, and net balance indicate increases. No changes have been identified for the City's accounting policies. Cash and investment portfolios were reviewed and found to be consistent with prior years, and comply with Wyoming State Statute. The retirement commitments related to the City's participation in Wyoming Retirement Systems were discussed. A large portion of liability for the City is located within Plan A of the Wyoming Retirement System. Post-employment benefits other than pension include the retiree health insurance plan and the subsidization liability was determined to be \$3 million in the past year. No issues of overspending were identified. Trend information for the last seven years was outlined. 20% of federal funding is examined. Section 8 housing was inspected to meet these criteria. Internal controls within the City are reviewed to identify significant deficiencies and material weaknesses, which none were found. The internal control over financial reporting according to government standards was discussed. Control for the City as a whole is reviewed. The Audit Committee Letter was presented prior to the meeting, these are the items required to be reported to the City Council as those charged with governance. The Audit Committee Letter was summarized. Ms. Wilson extended a thank you to Matthew L. McBurnett, Alex Visser, April Thompson and their staff for their cooperation during the auditors' visit. Mayor Kaumo expressed his appreciation to Mr. McBurnett and Mr. Visser as well, along

with Mrs. Thompson. He trusts that the City's financial condition is in good hands. He thanked Ms. Wilson for taking the time today to present the City with its audit. Mr. McBurnett reiterated Mayor Kaumo's thanks to staff for their hard work both during the audit and throughout the year, maintaining the general ledger and more to ensure a clean audit report.

Councilor West stated that from a budgetary aspect, we are hoping that this pay will be reimbursed after CARES Act funding. He is hoping that we can approve this with a contingency that CARES Act funding is approved, but has been informed that this is not possible. Councilor West is trying to figure out whether the City would be responsible for the cost of the \$30,000 that may not be successfully awarded. Commander Bill Erspamer stated that he is happy to explain any questions regarding the policy itself and what officers are actually doing to constitute hazard pay. Councilor West added that he understands that officers are at higher risk of not being prepared with the proper PPE during a call, and he understands that Wyoming State Troopers were awarded the funding and that it is looking hopeful. Commander Erspamer stated that some calls are self-generated on the spot for patrol officers, and that PPE could be removed from their person during a struggle with an arrest. The ideal is to wear PPE and it is worn, but in some instances it can be removed during an arrest or another unpredictable situation. Mr. McBurnett clarified that the cost estimation is at no more than \$20,000, and is for patrol officers or those who are covering shifts for patrol officers. Councilor Tate asked where the funding would come from should the grant funding not be awarded and Mr. McBurnett clarified that there are several unfilled, but funded, positions in the Police Department and the cost would be taken from this. Councilor Shalata asked about the term, and whether this would only be in effect during the COVID-19 crisis, or if it would extend past that. In the policy, it is from December 7, 2020, to January 7, 2021, in the hopes of being awarded reimbursement through grant funding.

Moved by Councilor Savage, seconded by Councilor Demas to approve Resolution 2020-173. Upon roll call the following voted in favor: Councilors West, Savage, Demas, Tate, Halter, Shalata, and Mayor Kaumo. Motion carried unanimously.

Mayor Kaumo stated that the community will hear the City Council and himself reminding everyone how important it is to keep our health and safety at the forefront, which includes wearing masks. Many meetings have been held over the week regarding mask mandates and the debate whether having one is needed. A letter has been sent to the Governor's office from County Health Officers around the state, asking for a mask mandate to come from his office. The City does not intend to institute a mask mandate. Logistically, a mask mandate would entail many jury trials taking place due to citations to those not complying with the mandate. He added that it is pretty easy for the Governing Body to realize that masks are important and may save the individuals next to you and around you. When physical distancing can't be met, throwing a mask on is a very easy thing to do. It is his concern that if something is not done soon, a mandate will be coming from the Governor's Office. If numbers aren't kept down, the mandate will come. This is being done to prevent inundation of health care and hospitals; to slow the spread. No one likes more government in their lives, but the last thing that he wants to see are businesses shut down. We as a community must be responsible, and wearing a mask when required and staying away from large gatherings are very important. The holidays are approaching quickly and numbers will spike again. Mayor Kaumo is pleading with the community to wear a mask. We are strong and responsible people. Put on a mask. 30% of those tested are coming in positive. Those numbers indicate a spike; they have increased from 3% to 30%. Thanksgiving break will indicate whether people are responsible or not; our numbers may go down, or they could quadruple. He is pleading with the community of Rock Springs to do the right thing. Wear your
