Ordinance 2021-15 AN ORDINANCE AMENDING ARTICLE 3-2, ENTITLED "OFFENSES CONCERNING PUBLIC MORALS AND DECENCIES", SECTION 3-244, ENTITLED "DAYTIME CURFEW", OF THE ORDINANCES OF THE CITY OF ROCK SPRINGS, WYOMING, was read by title on second reading.

Ordinance 2021-16 AN ORDINANCE AMENDING ARTICLE 5-2, ENTITLED "OPERATION OF MOTOR VEHICLES", OF THE ORDINANCES OF THE CITY OF ROCK SPRINGS, WYOMING, ADOPTING WYOMING STATUTES § 31-5-1301 - §13-5-1305 AND WYOMING STATUTES §31-5-1401 - §31-5-1402, GRANTING AUTHORITY TO THE ROCK SPRINGS MUNICIPAL COURT TO ENFORCE WYOMING STATUTES REQUIRING THE USE OF SAFETY BELTS, was read by title on second reading.

Ordinance 2021-17 AN ORDINANCE CREATING ARTICLE 10-11 OF THE ORDINANCES OF THE CITY OF ROCK SPRINGS ENTITLED "PERMITTING AND REGULATION OF MOBILE VENDORS," was read by title on second reading.

Section 10-1102 Definitions: Amend the definition of "Mobile Vendor" as follows: delete "within the City" and add the language, "for a period not to exceed 30 consecutive days on a single property. After locating on a single property for 30 consecutive days, the mobile vendor shall be considered a Stationary Mobile Vendor unless the mobile vendor relocates to a different property for a period of at least fourteen days prior to returning to the original property."

Section 10-1103 Mobile Vending Permit: In subparagraph B. 1., add item "i" to read as follows: "Proof of general liability insurance if operating on public property."

Section 10-1103 Mobile Vending Permit: Add subparagraph B. 4. to read as follows: "Incomplete applications will not be processed and shall be immediately returned to the applicant."

Section 10-1103 Mobile Vending Permit: In subparagraph G. 2., add the language, "The annual fee shall/shall not be prorated."

Councilor Zotti asked Matthew L. McBurnett for the reason of the recommendation not to allow proration of the permit fee. Mr. McBurnett stated that the occupation tax is not prorated, and these would be issued at the same time. No other permits are prorated. The system would need an override with every proration done. To be consistent with the fees, proration is not recommended.

Section 10-1105 Locations on Private Property: In subparagraph A. 1., after the word "owner," add the language, "or authorized representative."

Section 10-1106 Operation and Sales: In subparagraph A. 3. delete "8:00 p.m." and add "sunset."

Section 10-1106 Operation and Sales: In subparagraph F. 5. a., delete the language, "occur in a continuous manner at a permitted wastewater facility. The City Water Reclamation Facility may be contacted for this disposal during normal business hours. Vendors may also utilize permitted waste haulers to service the Mobile Vending Unit as long as no contamination of the ground or adjacent area occurs. Records of all disposal locations and/or services by a waste hauler must be maintained on the unit at all times for review at the request of the City of Rock Springs. This record shall include the location, date, time, and hauler name/contact information/certification information." And add the language, "be in accordance with the City Mobile Food Vendor Sector Control Policy."

Moved by Councilor Zotti, seconded by Councilor Demas to approve amendments to Ordinance 2021-17 as stated. Upon roll call the following voted in favor: Councilors Savage, Robinson, Demas, Zotti, Halter, Bettolo, West, and Hickerson. Motion carried unanimously.

Mayor Kaumo stated that all of these amendments have come from the mobile food truck vendors that attended the last meeting to provide input and feedback on the drafted ordinance. Councilor Zotti stated that this is what government is all about, and gathering input is how things get done. The entire community has a voice.

Changes made tonight will be reflected on third reading.
